Why are you running for this position? What in your background has led you to run? (Not to exceed 150 words) *

I am passionate about speaking up for the poor and marginalized in my community. Most of our working people in my area are fighting to get ahead, and their voices are not being heard. My main focus is to increase the safety net and increase the rights of workers to organize their workplaces. I'm the son of a teacher, and I have seen how important it is to have the protections and security that a unionized workplace provides. I hope to be elected to pass legislation that will make it easier for workers to organize and unionize their workplaces. I also believe that healthcare reform at the state level is possible. We can provide universal healthcare or a public option in WA State. I think that there is an opportunity to stand up for working people through legislation and law, and I hope to be the person that will make that happen.

Please explain how your campaign will address donations from utilities, fossil fuel companies, and corporate PACs? *

I will not accept contributions from organizations that have conflicting values. I am a strong supporter of environmentalism, and I will never accept money from utilities, fossil fuel companies, or corporate PACs that oppose our green transition.

What are your most significant accomplishments either as an individual, member of a group, or elected official on environment and climate change?

In my community the state airport commission attempted to put in airport nearby in Graham. I organized along with many members of the community to fight back and oppose this. While the fight is not over, its unlikely that any airport will be built in Pierce County due to these efforts. I have also spoken out against large warehouse development in Puyallup on King 5 news, and organized efforts to kill the approval of these mega projects eliminating our farmland and green spaces.

I have signed in and emailed my legislators on many housing bills, as good housing policy is good climate policy. I have also signed in and advocated for many public transportation bills in this past session as good public transportation policy is good climate policy.

If elected or re-elected what specific environment, climate change, biodiversity, transportation, building and land use, growth management, and/or environmental justice legislation will you prioritize and champion?

I believe we should expand environmental protections. That means clamping down on polluters and corporations and setting higher environmental standards. Washington has immense environmental beauty and diversity. We cannot let it be destroyed by bad actors who are more concerned with their bottom line than the health of their community. If elected, I will prioritize policies such as preserving and expanding protected areas and implementing sustainable land management practices, advocating for investments in public transportation infrastructure and incentives for electric and low-emission vehicles to reduce reliance on fossil fuels, and promoting smart growth and sustainable urban planning policies that prioritize mixed land use, affordable housing, and access to green spaces.

Washington State law sets a target of 90.5 million metric tons (MMT) carbon pollution by 2020, but greenhouse gas emissions rose last year to 102 MMT (Department of Ecology). The state is not on-track. For state office positions, what action will you take to accelerate efforts towards Washington State's 2030 Climate goals, specifically a 45% reduction of carbon pollution below 1990 levels?

Our state legislature is taking the right steps to address climate change, and we must continue this progress. Our natural spaces should be enjoyed and cherished, which means taking good care of them through stewardship. If elected, I will champion sustainable forestry practices and support renewable energy sources. These actions prepare us for long-term resiliency and save the environment for future generations.

Transitioning to a carbon-neutral economy is necessary, but it must be done equitably. We need to transition to renewable energy and nuclear energy. I am also a big fan of comprehensive public transportation and dense community planning to reduce our carbon footprint. This transition must also allow communities affected by our climate transition to participate fully in the decision-making process and ensure that they receive adequate support and resources.
