I am running for State Representative because, as a teacher and a working parent, I have witnessed firsthand the impact of policy failures on families in our community. Our schools, families, workers and natural world are facing challenges that demand thoughtful, effective solutions. I believe that my experiences as a teacher, father, and proud union member uniquely position me to understand and address

these issues. We need more legislators in Olympia who will prioritize families, workers' rights, addressing climate change, and competence in state government. I am committed to ensuring the voices of our community are heard and represented in the legislature.

Please explain how your campaign will address donations from utilities, fossil fuel companies, and corporate PACs? * I am not accepting donations from utilities, fossil fuel companies or corporate PACs.

What are your most significant accomplishments either as an individual, member of a group, or elected official on environment and climate change?

Most of my activism has been focused on labor and union advocacy. With that being said, I have always been a champion of policies and resolutions within the organizations that I serve to ensure that we are prioritizing the environment and addressing climate change. Though this may not count as significant, I made the switch to an electric vehicle in 2021.

As a Sequim Farmers Market Board member, I am proud to support and advocate for local agriculture and producers. As a member of the 24th Legislative District Democrats, I have supported resolutions to address climate change and reduce environmental impacts.

As part of the Washington Education Association, I supported resolution I-2 which calls for the teaching of climate change issues and impacts at all grade levels, through the lenses of science, social justice, civic duty and critical thought in other subjects. This resolution recognizes that climate impacts are disproportionately felt by disadvantaged communities and communities of color.

If elected or re-elected what specific environment, climate change, biodiversity, transportation, building and land use, growth management, and/or environmental justice legislation will you prioritize and champion?

Being from the Olympic Peninsula, I know the importance that our local forests have in carbon stores that must be protected. Multiple groups, such as Elwha Legacy Forests and the Center for Responsible Forestry, are working towards improved land use policies. I do not support harvesting timber as a method of supplemental funding for education. We should preserve legacy forests and decouple junior tax districts from tracts of land. I would be a champion of these and similar measures in the Legislature, and I am eager to work with other advocates and agencies to identify smart land use investments, as well as change policies to promote long-term resiliency.

In addition, local governments have drafted climate resiliency plans and will need assistance to see those plans through, so I will work with stakeholders to find funding for climate resiliency measures. Although I'm hopeful that the Climate Commitment Act repeal initiative will fail, I will continue to advocate for its importance and expansion within our state.

Washington State law sets a target of 90.5 million metric tons (MMT) carbon pollution by 2020, but greenhouse gas emissions rose last year to 102 MMT (Department of Ecology). The state is not on-track. For state office positions, what action will you take to accelerate efforts towards Washington State's 2030 Climate goals, specifically a 45% reduction of carbon pollution below 1990 levels?

As far as I understand, there is currently no viable industrial carbon capture technology, so we have to support and lift up the scientists and stakeholders who are working for solutions that are not motivated by profit, and call out those loud voices that wish to destroy our working and natural lands to enrich shareholders at the expense of climate mitigation. Protecting carbon-storing forest lands would help with decreasing the amount of carbon in our atmosphere, and from there we can work on both holding companies accountable for current pollution and researching ways to reduce both private and public carbon pollution.

Additionally, I would sponsor and support measures promoting housing density, improving public transportation, and advancing walkability and bicycle infrastructure in cities and towns of all sizes. I look forward to conversations with advocacy groups and stakeholders on how best to reach the state's climate pollution targets.
